

THE EMERGENCY TENANT PROTECTION ACT

DON'T GET PRICED OUT OF OSSINING!

The "Emergency Tenant Protection Act" (ETPA) would do the following for tenants living in buildings of 6 units or more built before 1974:

- Limit how much rent can increase
- Require tenants to be given 1- or 2- year leases
- Entitle tenants to receive repairs, heat, hot and cold water, maintenance, elevator and other essential services
- Protect tenants from landlord harassment
- Make it possible to freeze rents for eligible Seniors and people with disabilities
