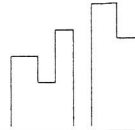

## "SOURCE OF INCOME" NON-DISCRIMINATION IN RENTING

### IT'S THE LAW !!!

EARLIER IN 2013, THE *WESTCHESTER COUNTY BOARD OF LEGISLATORS (W-BOL)* PASSED AN ORDINANCE MAKING IT ILLEGAL FOR LANDLORDS TO DISCRIMINATE WHEN RENTING APARTMENTS TO PROSPECTIVE TENANTS BASED UPON THAT PROSPECTIVE TENANT'S "SOURCE OF INCOME", E.G. SECTION 8, *DEPT. OF SOCIAL SERVICES "SHELTER SUPPLEMENT"*, ETC. THE COUNTY EXECUTIVE SIGNED THE ORDINANCE AND THE LAW TOOK "FULL EFFECT" AS OF 12/23/13.

THE GOVERNMENT AGENCY WITH EXECUTIVE OVERSIGHT OF THE LAW IS THE *WESTCHESTER COUNTY HUMAN RIGHTS COMMISSION*. THE COMMISSION'S EXECUTIVE DIRECTOR, MARK FANG WILL BE COMING TO *MOUNT VERNON UNITED TENANTS (MVUT)* TO EXPLAIN THE LAW AND ITS IMPLEMENTATION"
